ACTING EXECUTIVE OFFICER MURRAY BAIRD REPORT

I was pleased to step in for an interim period following the departure of Mary-Anne Perry in September 2019. Mary-Anne gave leadership and management to Westgate Health Cooperative over the past 7 years. I arrived just in time to enjoy her farewell function and hear the tributes to her achievements over her service to Westgate Health. At the time of writing this report in October 2019, processes are well in place to identify and appoint her successor.

I could not review the year from my personal knowledge due to my late arrival. However, I can make some observations from my brief time with you.

Although there have been turbulent times in the governance of the cooperative in the past year, the day to day care of members has continued in the way it has done for decades. The changes of recent days have provided the opportunity to review several aspects of our work and I am confident that the review led by Susan Pascoe will be a resource to strengthen the Cooperative for some time to come.

Our staff of doctors, nurses, receptionists and administration staff have continued to give exceptional service in difficult circumstances, and I pay tribute to their loyalty and professionalism. As members (and I was pleased to join up!), take the opportunity when you can to thank them for their contribution to our lives.

The finances of the Cooperative remain healthy with a modest surplus. As we are a Not for Profit charity, this is not an end in itself. However, it does provide the means to continue the caring that we provide without financial uncertainty. We have also been able to contribute just over \$50,000 to our charitable fund where we are steadily building resources so that we can make a long-term difference to our community.

I heard recently of a successful football club where the President observed that there were values beyond the core activity – in their case football. She said this:

"We exist for a deeper purpose. It's about connecting; connecting with each other and our culture and connecting externally. We believe we have a role to play in connecting with the community, in strengthening and unifying community, in creating social value".

May I urge you as members not to see Westgate Health as just another medical clinic but a unique member -driven community of connection, caring and health giving.

Surplus down but still healthy

I am pleased to report to members that the finances of Westgate Health Cooperative remain strong. Our surplus for the year was just over \$100,000. Our revenue was down on last year for several reasons including a shortage of doctors. There were also some additional expenses around governance issues. However, the result is sound and we continue on a good financial base to deliver services to our community.

Renovations complete and now for Utilisation

We have now completed renovations at both sites from our existing resources and the Board is considering how to optimise our use of the facilities. Our strong cash position allows us to expand our services where appropriate.

Charitable Fund Grows

The Charitable Fund continues to build which will enable us to contribute more to the community in the future from a substantial capital base. The total of the fund stood at \$444,195 at 30 June 2019.

A good base for the future

In summary, Westgate Health Cooperative finances are healthy and provided a good base to continue delivering excellent services.
